
The 2025 Risk Management Award Winners

Category: Collaboration with Local/Community Organization Award

Cuyahoga Metropolitan Housing Authority, OH - Scan for Safety

Through a collaboration with the City of Cleveland Fire Department, the Cuyahoga Metropolitan Housing Authority implemented Quick Response (QR) Codes at developments with monitored fire alarm systems. QR Codes link to building and contact information such as fire alarm control panel details, sprinkler – standpipe type and locations, stairways, emergency generator, shut off valves and special information specific to the development. The QR Codes facilitate immediate access to building information that safety forces would not otherwise have at the point of emergency response. The QR Codes are maintained in the "Knox Box" for Fire and Police as well as inside the Fire Alarm Control cabinet.

Category: Best Use of Grant Program Funds

Syracuse Housing Authority, NY - Door Access Control Upgrade Program

Several of our agency's properties were experiencing increased criminal activity and unauthorized building access, adversely impacting residents' and employees' safety, security, and well-being. Building residents expressed concerns about their safety and security at tenant association meetings, contact with property managers, and with increased security request calls. These properties utilized a Hirsch door access system, which we started using in 1996. We were experiencing difficulties upgrading the system to make it more secure. We could not effectively service the system due to an inability to secure replacement parts, as the technology is obsolete. Therefore, we sought to upgrade our door access control systems for gaining entrance to the properties thus mitigating risk for potential property damage and or loss, personal injury and or death, criminal activity, any of such could result in insurance claims, with the overall goal of increasing the resident community and employees' security while preventing inadequate security claims. Research has shown that environmental methods, such as access control systems, can help mitigate opportunities for criminal activity and lead to crime prevention while providing security to building residents.

Category: Employee Safety Award

Opportunity Home San Antonio, TX - Toolbox Talks! Safety Skills for Employees

Opportunity Home San Antonio proactively addresses loss prevention and enhances employee safety among its maintenance teams through a monthly "Toolbox Talks! Safety Skills for Employees" program. This initiative delivers concise, job-relevant safety training on distracted driving, slips, ladder safety, and mental health, facilitated by trained supervisors using provided materials. To ensure engagement and consistent participation, a streamlined QR code system tracks attendance, and timely submissions enter teams into a monthly raffle for a snack box, fostering a positive safety culture where employees actively support each other's well-being and

safe work practices, ultimately aiming to reduce potential injuries and workers' compensation claims. This easily replicable program demonstrates positive results in increased safety awareness and peer support.

Category: Resident Safety Award

Opportunity Home San Antonio, TX - Proactive Fire Prevention: Implementing Auto Stove Shut-Off Technology for Enhanced Resident Safety and Reduced Housing Losses

The FireAvert Auto Stove Shut-Off program enhances fire safety within Opportunity Home San Antonio's mid-rise and high-rise public housing communities by installing FireAvert devices in resident units. These devices are designed to automatically interrupt power to electric stoves upon the activation of smoke alarms, effectively mitigating the risk and severity of cooking-related fires. This initiative aims to protect residents and reduce property losses associated with stove fires by providing an automated safety mechanism triggered by existing smoke detection systems.

Category: Risk Champion of the Year

Decatur Housing Authority, NE – Risk Champion Jason Pounds, Maintenance Man

Jason was hired two weeks after the embezzlement/fraud was discovered, as a part time maintenance man at this property. He was brought into an absolute mess but has always gone above and beyond his job description. He was hired part time but has volunteered/donated so many more hours. He is always donating materials or supplies to make sure safety concerns are corrected. After his already worked week, Jason and his wife often spend most of their nights and weekends trying to catch the property back up from being neglected. Tenants will flag him down and ask for help on their personal projects, lifting, or reaching things and he never hesitates. He has such an incredibly huge heart and truly cares about the safety of the property and the tenants.

2025 Risk Management Award Honorable Mentions

Easton Housing Authority, PA - The ADA Asphalt Patching Program

The ADA Asphalt Patching Program focuses on repairing damaged curbs and sealing edges to enhance safety and accessibility for all residents. The process begins with a detailed assessment to identify and prioritize areas needing repair, followed by planning and resident notifications about schedules and potential disruptions. Experienced contractors will remove damaged asphalt, apply new material, and seal edges, ensuring compliance with ADA standards through quality checks and post-work inspections. Safety measures, including clear markings and alternative routes, are implemented throughout. Resident feedback is actively sought to refine future efforts, ensuring a comprehensive and community-focused approach to maintenance.

Opportunity Home San Antonio, TX - Lead Based Paint Project-Lincoln Heights Apartments Renovation

To proactively address lead-based paint concerns, Opportunity Home San Antonio has engaged Alamo 1, a comprehensive environmental services contractor. Alamo 1 has been tasked with a phased renovation of all buildings and individual units to ensure the complete and thorough removal of all lead-based paint.

Opportunity Home San Antonio, TX - Opportunity Home collaborates with Metro Health and Animal Care Services for Rabies and Bite Prevention Training

Opportunity Home San Antonio has teamed up with the Metro Health Department and Animal Care Services to equip our employees with crucial knowledge of rabies and bite prevention. This comprehensive training covers essential topics, including understanding rabies, immediate steps to take following a bite, effective bite and rabies prevention strategies, the proper procedure for reporting incidents to Animal Care Services, and an overview of Texas' Dangerous Aggressive Dog laws. Animal control in San Antonio is not just about handling stray animals, it's a crucial public service that directly impacts residents' and animals' safety and well-being. Given the reported issues with dog bites and fatalities in San Antonio, a well-funded, efficient, and proactive animal control agency is essential to address these problems, enforce responsible pet ownership, and ultimately create a safer community for everyone. Metro Health partners and provides training with Animal Control to Opportunity employees for self and to better support our residents.

Syracuse Housing Authority, NY - Collaboration - Neighborhood Health & Wellness Fair

Syracuse Housing Authority (SHA) is collaborating with two local community organizations, i.e., Brady Market (through Brady Social Enterprises, Inc.), and Le Moyne Center for Aging Resources and Enrichment (CARE) to host an annual (held every September) Neighborhood Health and Wellness Fair (NHWF) for our residents and the wider local community of the Westside of Syracuse, New York (NY). The goals for the NHWF are to connect SHA and local Westside community residents with Health & Wellness agencies and organizations in empowering them with information, education and available resources related to health, safety, security, wellbeing, and wellness, to provide enhanced access while improving health outcomes and overall quality of life for individuals and families in the neighborhood. The NHWF intends to introduce these residents to outside agencies they might not have the ability or awareness to seek out, which can provide appropriate and related services. The residents can meet and interact with local agencies and organizations to collaborate with individuals, families with children, Youth at Risk, Teens, Seniors, and individuals with disabilities.

Dowagiac Housing Commission, MI – Risk Champion Beverly Weston

Bev takes care of everything related to the PHA. Over the past year, she has turned our struggling agency around, reducing our debt from approximately \$123,000 to almost current. The previous Executive Director mismanaged the agency's funds, putting us on the brink of closing our doors. Bev has been amazing. She has fulfilled all of HUD's requirements as well as those of the auditors and our Board of Commissioners' requests. She has worked tirelessly, putting in countless hours to keep the agency afloat. Despite her significant contributions, she often does not take the credit she deserves, and she truly deserves a lot!

Opportunity Home San Antonio, TX – Risk Champion Jennifer Dominquez, Senior Risk Manager

Jennifer is a highly deserving candidate for the HAI-Risk Champion Award due to her exceptional dedication to risk management. She has consistently implemented innovative solutions, significantly enhanced operational efficiency, and prioritized the safety of the organization and all stakeholders. Mrs. Dominquez strategically integrates technology to optimize risk management services and provides leadership to her team, ensuring the most effective utilization of the organization's resources. Her approach is characterized by a strong focus on innovation and data-driven decision-making, underscoring the importance of employing creative and strategic methodologies. Jennifer has instituted QR code-based systems for training materials and attendance registration, which streamline attendance tracking and eliminate legibility issues associated with handwritten records. Furthermore, Jennifer has generated QR code decals for all fleet vehicles. Each vehicle displays a windshield decal with the QR code linked to the current insurance information, mitigating the issues of paper insurance cards, lost cards, misplaced cards, and uncollected cards.

Hampton Housing Authority, GA – Risk Champion Shakia Osbia

This award should be given to our Board Chair Shakia Osbia because she ensures that our board stays proactive, not reactive, in identifying emerging risks. She enhances board awareness and integrates risk discussions into strategic planning.

Housing Authority of the Town of Greenwich, DBA Greenwich Communities, CT - Risk Management through Modernization - Greenwich Close Apartments

At Greenwich Close Apartments, a 130-unit complex comprised of three, four-story buildings, we have made significant upgrades as part of our ongoing commitment to safety and risk management through modernization. These improvements include a new fire alarm system, live-water stairwell standpipes, and a number of tenant related security upgrades that promote safety and security.

Peoria Housing Authority, IL - Ameren Illinois Energy Efficiency Initiative

The Peoria Housing Authority (PHA) partnered with Ameren Illinois, Peoria's primary utility provider, to implement a portfolio-wide energy efficiency initiative under the Ameren Illinois Multifamily Direct Install Program (PA 2025 (003).pdf). This collaboration enhances resident safety and reduces operational losses across 764 units in Harrison Homes (AMP 2, 152 units, 68 occupied) and River West (AMP 7, 76 units), aligning with HUD's energy conservation standards (24 CFR 965 Subpart C) and Peoria Municipal Code, Chapter 5, Section 5-141 (energy-efficient building standards).

Housing Authority of the City of Milwaukee, WI – Risk Champion Public Safety Department

The HACM Public Safety Department is responsible for ensuring the safety and security of residents, staff, and properties across all HACM developments and locations. Their responsibilities include strategic patrol deployment, safety walk-throughs, coordination with law enforcement and community partners, oversight of dispatch operations, implementation of surveillance technology, and promoting a culture of accountability through training and internal standards. The department operates on a 24/7 basis, responding to calls for service, conducting investigations, and providing visible deterrence through foot and vehicle patrols. Their work is rooted in fostering trust, transparency, and responsive community policing tailored to the needs of public housing residents.

Kansas City Housing Authority, KS - The agency's safety program aims to reduce workplace injuries by educating and training employees on safe work practices.

The agency's safety program emphasizes training, education, and awareness through articles, conversations, emails, videos, and an incentive initiative. New employees are introduced to the program during orientation, where they learn the importance of reporting all injuries—regardless of severity—and near misses to their supervisor or Human Resources.

Peoria Housing Authority, IL - CFP-Funded Vacancy Reduction Initiative

The Peoria Housing Authority (PHA) leverages HUD's Capital Fund Program (CFP) grants to implement a vacancy reduction initiative, part of a multi-phase unit upgrade plan initiated in April 2023, to restore habitability and reduce operational losses across 764 units in Scattered Sites (AMP 3, IL003000003) and River West Homeownership (AMP 7, IL003000007). Funded under 24 CFR 905, the initiative renovates vacant units to address safety hazards, boost occupancy, and ensure decent, safe, and sanitary housing per HUD regulations (24 CFR 966.4(h)) and Peoria Municipal Code, Chapter 5, Section 5-31.

Peoria Housing Authority, IL – Risk Champion Justin Reynolds, Director of CFP

Justin Reynolds deserves the Risk Champion of the Year Award for his exceptional leadership in advancing our agency's risk management efforts. As Director of CFP, Construction, Development, and Fleet, Justin has spearheaded critical initiatives, including the CFP-Funded Vacancy Reduction Initiative, which utilized \$233,512.61 in grants to restore 6 Scattered Sites units and plan for 39 more, reducing revenue losses and safety hazards. His oversight of emergency repairs, such as \$85,000 in mitigation at 1125 SW Jefferson, 521 S MacArthur Hwy, and Harrison Homes, mitigated health risks and ensured resident safety. Justin's implementation of a QR code-based inventory system addressed HUD's recommendations, enhancing employee safety by reducing warehouse hazards. His strategic coordination of partnerships, like the Ameren Illinois Energy Efficiency Initiative, and compliance with HUD (24 CFR 905) and Peoria codes (Chapter 5) have strengthened PHA's operational stability, making him a pivotal leader in our risk management success.

Omaha Housing Authority, NE - 1st Annual OHA Employee Spring into Wellness Fair

The 1st Annual OHA Employee Spring into Wellness Fair took place on Wednesday, April 16th from Noon to 3:30 PM at the Goodwill Training Center @ Stockyards Plaza (3505 L. Street, Omaha, NE). This event was open to all OHA employees and took place to promote and encourage wellness, connection, and education. This event was attended by over 18 community organizations and a delicious lunch was provided to both employees and community partners.
